GALLERY HIGHLIGHTS ALSO INCLUDE THE ONLY PERMANENT DINOSAUR EXHIBIT IN DELAWARE, A SIMULATED CORAL REEF, AN INVESTIGATION LAB, AND A SCIENCE IN ACTION LAB.
